

# TEMPORARY VISITOR GUIDELINES:

## CHANGES DUE TO COVID-19

In response to COVID-19, we have temporarily changed our visitor guidelines to comply with physical distancing guidelines and to safely care for as many children as possible.

- In most inpatient areas, **two fully vaccinated parents/carers** can accompany a patient at a time. They must show proof of vaccination to concierge staff. If unvaccinated or partially vaccinated, only one parent/carer can be with a patient at a time.
- Due to space constraints and the need to maintain physical distancing, **one fully vaccinated parent/carer can accompany a patient** in the Emergency Department, Outpatients Department, Ward C2 North, Short Stay Surgical Unit, Medical Day Unit and COVID wards. If you are unvaccinated or partially vaccinated, please speak to a member of staff.
- Siblings are not able to visit at this time. Where space permits, siblings of long stay patients (more than nine days in hospital) are welcome to visit at a time pre-arranged with the ward's nurse leader.
- We encourage virtual visits using platforms like Facetime or WhatsApp. If you need access to a tablet for video conferencing, please speak to a member of your child's health care team.
- All visitors will be screened upon entry and must stay home if sick or if they have visited a COVID-19 case location.
- All visitors over the age of 12 are required to wear a mask in all areas of the hospital, except when drinking, eating or sleeping.
- Hand washing and physical distancing guidelines should be maintained at all times, to help protect vulnerable patients and families.
